WAIVER

WARNING: READ CAREFULLY. THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE CATHEDRAL OF THE PINES AND OTHER PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU have questions.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

In consideration of Cathedral of the Pines allowing me to participate in the Cathedral of the Pines 5K Trail run-walk, I, and on behalf of my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representations pursuant to this Waiver and Release of Liability, Assumptions of Risk and Indemnity Agreement.

1. I hereby represent that I am in good health and in proper physical condition to participate in the Event and I am not under the influence of alcohol or any illicit or prescription drugs which in any way would impair my ability to safely participate in the Event. I agree it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event.
2. I understand and acknowledge the physical and mental rigors associated with trail running and realize that portions of this event could be inherently dangerous and represent an extreme test of a person's physical and mental limits. I understand that participation involves risks and dangers which include, without limitation, the potential for serious bodily injury, sickness and disease, permanent disability, paralysis and loss of life, loss of or damage to equipment/property; exposure to extreme conditions and circumstances; accidents, contact or collision with other participants, spectators, vehicles or other natural or manmade objects; dangers arising from adverse weather conditions; imperfect course conditions; water, road and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event organizers; and other defined risks and dangers which may not be readily foreseeable or are presently known risks. I understand that these risks may be caused in whole or part by my own actions or inactions, the actions or inactions of others participating in the Event, or the acts or inactions of the Released parties, and I hereby expressly accept and assume all such risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in the Event.
3. I agree to be familiar with and abide by the Rules and Regulations established for the Event.
4. I hereby release, Waive, and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: The Event owners, organizers and promoters, Sponsors, Advertisers, Host Cities and Venue, and property upon which the Event takes place, and each of their representatives, affiliated companies, agents, employees, and volunteers. With respect to any liability claim(s), demand(s), cause(s) of action, damage(s), loss or expense of any kind of nature which may arise out of, or result from, or relate to my participation in the Event. I further agree that, despite this agreement, I or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend, and hold harmless each of the

6. I hereby warrant I have read this Agreement carefully, and understand its terms and conditions. I acknowledge that I have signed this Agreement freely and voluntarily, without any inducement, assurance or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions, and provisions of this Agreement. This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of the Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement, and shall not affect the validity and enforceability of any remaining provisions.
